**SANCTION:** This Contest is sanctioned by the National Physique Committee of the USA (NPC). SANCTION #15082

**ELIGIBILITY FOR ALL EVENTS:** Open to National Physique Committee (NPC) registered athletes residing in the Central District of Florida who must present current NPC card and driver's license as proof of residence. Over 30, 40, 50, 60 competitors must have reached that age on or before June 3, 2017 and provide proof of same. Novice competitors who have placed first, second, or in an open division are not eligible for Novice competition. A competitor who has won a weight class in a Novice division may not compete again as a novice. NOTE: If you are a new or previous NPC Competitor and are unsure for which event you qualify, please call us for verification. **\* Per Florida Law: NO alcoholic beverages are allowed on school property. Competitors using alcoholic beverages or in possession of any alcoholic beverage will be immediately disqualified and subject to arrest!!!**

**\* COMPETITORS PLEASE NOTE:**

**ATTN: BIKINI COMPETITORS:** The bikini competitor will be judged wearing a two-piece suit preferable "off the rack" type suit. Suit must be worn at the weigh in for determination of proper fit. The bottom should be in good taste covering about 50% of the gluteal area. No thong type suits will be allowed. If the athlete has any questions they should bring a second suit with a more modest bottom. The final decision will rest with the District Chairman or his representative at the competition.

**FIGURE & BIKINI:** All figure and bikini competitors must check-in Friday night. **ATTENTION!** An important meeting will be held from 5:30 p.m. to 6:30 p.m. in the auditorium for all female competitors – Figure & Bikini Champions and assistants will be there for questions and answers. The show director will conduct the meeting.
